#### NJ Manufacturers Insurance

Employees and their family members are eligible to apply for insurance through the New Jersey Manufacturers Insurance Company ([NJMIC](#)). To apply, call 1 (800) 232-6600 ext. 4515 and reference the **MSU eligibility #86354-8**. A valid MSU ID Card is required. The NJMIC is located at 301 Sullivan Way, West Trenton, NJ 08628.

### VISION CARE

Full-time employees and eligible dependents may receive a \$40 reimbursement toward the cost of prescription eyeglasses with regular lenses, \$45 reimbursement for glasses with bifocal lenses, or a \$40 reimbursement for contact lenses. Receive a maximum reimbursement of \$35 toward the cost of an eye examination given by an ophthalmologist or optometrist.

These reimbursements are available to each eligible employee and dependent once in every two-year period. Proper affidavit and submission of original receipts are required in order to receive payment. Vision care reimbursement **forms are available from the Office of Payroll Services.**
