Undergraduate Estimated Cost of Attendance Fall 2019 and Spring 2020 (12 - 18 credits per semester; 24-36 credits per academic year)

Montclair State University offers a flat tuition and fees rate for undergraduate students. The flat rate allows students to enroll from 12 to 18 credits per semester for the same cost. International undergraduate students must enroll in a minimum of 12 credits per semester, but the flat rate gives students the opportunity to enroll in up to 6 additional credits with no increase in costs. Flat rate out of state tuition and fees are estimated at \$21,396 per year. So, whether the student enrolls in 12 credits or 18 credits per semester, the tuition and fees are the same.

The Code of Federal Regulations requires Montclair State University to verify that prospective students have sufficient funds to be able to live and study in the U.S. for their first year of study before being issued an I-20 (F-1 students). The tables below describe the <u>estimated</u> minimum cost of living in the U.S. and studying at Montclair State University for <u>9 months</u> (one academic year). These estimates do not include the cost of living and studying in the summer; if you plan to remain in the U.S. during the summer, you will need to ensure you have additional funds for tuition and fees, living expenses, and other expenses.
