- Students who meet eligibility requirements may take JUST 497 one semester prior to their last semester.
- Internships requiring background checks can take as long as eight weeks for clearance. National/Federal clearance can take six to nine months and internships are highly competitive.
- You may be responsible for finding your own internship if you are arrested during the process, have a juvenile/adult arrest or conviction, or do not pass a background check. Please advise the Internship Coordinator of any charges or arrests you have incurred in the required meeting.
- Students who are not U.S. citizens may encounter difficulties in securing certain internships.
- The Internship Coordinator cannot guarantee placement at any site, or at a specific location.
- Final decisions are made by the site based on background clearance, strength of your resume, and interview.
- At all times students are encouraged to remain vigilant about finding an internship, as JUST 497 is a degree
- requirement, and it is ultimately your responsibility to complete all requirements (at all stages) for this course.
