

MONTCLAIR STATE UNIVERSITY NOTICE TO BIDDERS

The Director of Procurement Services at Montclair State University will receive bids for Request for Proposal # 1442–Panzer Gym Floor and Bleachers, through 10:00 AM, June 4, 2020 when they will be publicly opened at the Lobby Atrium of the Overlook Corporate Center, 150 Clove Road, Little Falls, NJ 07424.

A Pre-Bid Meeting and Site Inspection will be held on May 15, 2020 at 11:00 AM at the Panzer Gym lobby, Montclair State University, Montclair, NJ. Bidders are advised that attendance at both the pre-bid meeting and site visit is strongly recommended, and no special consideration will be provided to any bidder that does not attend.

Bidders are required to follow public health guidelines regarding social distancing and protective wear. Face coverings and gloves must be worn at the pre-bid meeting/walk through and bid opening.

When inside buildings, the number of bidders allowed inside at any one time will be limited and a rotational basis will be used to allow bidders inside any buildings.

Scope of Work: The project consists of resurfacing and restriping of the Panzer Gym Floor to include updated graphics and new NCAA 3-point line standards. Add Alternates to include automation of the bleachers, repairs to HVAC vents, and installation of new crash padding.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 et seq. regarding Affirmative Action; State of New Jersey Prevailing Wage Rate Act, N.J.S.A. 34:11-56.26 et seq.; and N.J.S.A. 52:25-24.2 regarding Ownership Disclosure. Bidders shall also be classified by the Division of Property Management and Construction (DPMC). Montclair State University is an Equal Opportunity Purchaser.

In accordance to N.J.A.C., 17:14-1.2 et seq. and Executive Order 71, signed by Governor James E. McGreevey in 2003, the University requires bidders to make a good faith effort to provide opportunities for Small Business Enterprises (SBE) to participate in the performance of this contract as subcontractors consistent with the overall goals established for construction services by the New Jersey Commerce and Economic Growth Commission (NJ Commerce).

SBE subcontracting goals are not applicable if the bidder is currently registered with NJ Commerce as an SBE firm.
