President Cole's Retirement

Dr. Cuss delivered the following remarks:

As I am sure you are now aware, President Cole recently informed the Board of Trustees that it was her intention to retire at the end of this academic year. The retirement of a long-serving president who has led an extraordinary institutional transformation over more than two decades, will undoubtedly be a profound change for the University. So much of the University's vision, identity, and relationships are intricately associated with President Cole, who brought unwavering commitment, passion, and skill to her leadership role. However, as she has said on numerous occasions, the depth of talent throughout the University is tremendous, and all together we have built a stable, resilient, creative and high-achieving institution; which has a secure foundation and a bright future.

The Board is very grateful that the President has committed to continue to lead the University through this incredibly challenging year; until next July 1 or beyond should additional time be necessary for the appointment of the next president. The Board of Trustees will be undertaking a <u>national</u> search in the months ahead and will, by early October, announce the details of the search process.

During this academic year we will take time to look back and celebrate President Cole's and the University's achievements, but for the present, under her firm leadership, the University must stay focused on the work before us, so we can navigate successfully the difficult challenge we face. I speak for the entire Board in expressing our hope that this very special University community will, as it has always done, continue to pull together for our students, for each other, and for the mission and values that we share.

Matters Presented By The President

President Cole reported that enrollment is strong for the fall semester. Instruction is proceeding online, inperson, and a combination thereof. President Cole expressed her pride in the fact that the students are following Covid-19 protocols and are practicing social distancing, both in their studies and in the residence halls. The University will be launching a "get your flu shot" campaign and will be providing free flu shots on

campus. The College Hall construction project is coming to a close. The delayed completion date was caused by the general contractor's inability to surce materials during the pandemic. President Cole acknowledged the efforts of our laboratory staff, who were keeping our research labs open. The University exceeded \$20 Million in external funding this year and Professor Rotella received a \$3.5 Million National Institute of Health grant. In closing, President Cole thanked the faculty and staff who have kept the University running in support of the 21,000 enrolled students.

Academic Affairs and Facilities

Mr. LaRossa reported that the Academic Affairs and Facilities Committee reviewed the minutes from its July 15, 2020 meeting, received a capital project report, reviewed the Clery report, and received a report regarding the Fall 2020 semester.

Faculty Representative to the Board of Trustees Elizabeth Emery remarked that she had been asked by a number of faculty members to thank the instructional technology design team, Facilities, and the professional staff for their efforts in getting the University ready for the fall semester.

Dr. Cuss made the following remarks:

I appreciate that the members of the University are experiencing a range of emotions and thoughts about the recently announced retirement of our long-serving President, which will occur at the end of this academic year. Given the commitment and passion of President's Cole leadership and the extraordinary progress this University has made, it is only natural that there will be some degree of anxiety about such a significant change. I want to assure you that the Board of Trustees is deeply aware of the importance of its statutory responsibility to appoint the next president and is fully committed to appointing the very best candidate.

The Board will undertake a national search for the new president. Guided by the Board's knowledge of the University, most of its members having served as Trustees for many years, and by the Strategic Plan recently developed by the campus community and adopted by the Board of Trustees, the Board is currently developing a position description, highlighting the characteristics it seeks in the successful candidate for president. The Board will welcome any written comments from the University community on the profile and will set up a mechanism for their receipt. The Board will conduct the search with the assistance of a prominent consulting search firm that has successfully assisted in the appointment of excellent presidents in comparable institutions. Selection of the search firm is currently on-going, and I expect to announce the formal selection by the end of October.

Today, the Board of Trustees will establish an ad hoc special committee of the Board to serve as a Presidential Search Committee to conduct the initial stage of candidate review and to recommend to the Board of Trustees a slate of final candidates for the Board's consideration. The full Board of Trustees will then consider those candidates and will select the appointee. In order to attract and retain the best candidates, the search will be

conducted with strict confidentiality throughout. The Board has every reason to think that it will be able to conclude the search process before June 30, 2021. However, in the unlikely event that this does not occur, President Cole will remain in office for whatever time is necessary to conclude the search.

the November 3rd presidential election. College Hall is now open and serves as the home to the student services one-stop Red Hawk Central. President Cole saluted the women's basketball team for taking the initiatve to build an outdoor basketball court to practice on while the indoor facilities remain closed to team activities. President Cole also highlighted Professors Pascale LaFountain and Thomas Herold for their work resulting in the University's German program being declared a Center of Excellence in German. The University has also received extensive recognition regarding its choral program, which turned the Red Hawk Deck into a performance space and was recently featured on the nationally televised Kelly Clarkson Show. President Cole recognized Professor Mayida Zaal, who received \$500,000 from the Spencer Foundation's Large Research Grant on Education for her study "Teacher Diversity, Retention, and Muslim-American Teachers".

Matters Presented by the Chair – Dr. Francis Cuss

Dr. Cuss reported that in Closed Session the Trustees reviewed the minutes from October 30, 2020, reviewed legal matters, and considered Troy Sessoms' appeal of the denial of his request for reclassification.

Sessoms Reclassification Appeal

Dr. Cuss moved that the Board approve the Final Administrative Determination of the Board of Trustees affirming the denial of the request for reclassification in the matter of Sessoms v. Vernon. The motion was seconded and approved unanimously.

No. 3304

Matters Presented By The President

President Cole reported that the University community concluded the fall semester safely and without unanticipated disruption in the face of the Covid-19 pandemic. Dr. Cole acknowledged it was a difficult semester for the entire University community, and that student feedback would be sought to improve the

spring semester student experience, including more in-person instruction and campus activities. Winter session enrollment has been strong, with a 24% increase year over year. The University has partnered with Passaic County to host a Covid-19 testing site on the campus and there is consideration ongoing in regard to the possibility of an on-campus vaccination site in the future. Dr. Cole announced several major gifts, an approximate \$2 million gift from a 1968 alumnus, a \$1 million gift from a 1961 student athlete, and 2 gifts totaling \$750,000 for the Center for Cooperative Media in the School of Communications from the Democracy Fund and the Bill and Melinda Gates Foundation. President Cole wished the University Community a safe and healthy winter break.

Union Report

Professor Richard Wolfson spoke on behalf of AFT Local 1904. He urged the Board to reconsider not having a formal AFT representative on the presidential search committee. Professor Wolfson recognized the students' hard work in completing this difficult semester and congratulated the professional staff being reappointed. Profesor Wolfson expressed support for the international student recruitment contract and requested that the University provide Covid-19 testing to faculty and staff during the spring semester.

Personnel, Nominations, Compensation and Governance Committee

Mr. Sluyter reported that the Personnel, Compensation, Nominations and Governance Committee reviewed the minutes from its October 30, 2020, meeting, proposed personnel actions and a list of new hires anticipated before the Board's next meeting.

Reports

Student Government Association President Ernst Lozin thanked the administration for its efforts in making the fall semester successful and safe. President Lozin stated that the SGA would encourage all students to receive the Covid-19 vaccine once it is available and that he was hopeful the spring semester would allow for more in-person activities. The SGA worked with the Montclair State University Police Department on promoting unity on campus. President Lozin expressed the biggest lesson he learned during his tenure was that the students truly do matter at the University and there is a resource to meet each of the students' needs. The University is very transparent in dealing with the students and they feel they have a voice.

University Senate President Erik Jacobson, a professor in the Teaching and Learning Department introduced himself to the Board. Professor Jocobson believed the semester went well and that the students and faculty alike have learned a great deal about remote instruction. Professor Jacobson acknowledged the professional staff's committeed efforts in making the semester a success. The Academic Affairs Council, the Administrative Affairs Council and the Student Affairs Council are all working on efforts to improve students' experience. This includes efforts to re-imagine the nature of core courses, establishing shared teaching principles and responding to student concerns about on-campus life. The University Senate has a full agenda for the spring – making sure students can maximize their learning, providing academic and other support as the pandemic continues, and engaging in research and the other activities that make Montclair State University a vibrant campus. Ensuring that this is done in keeping with the university's commitment to social justice and equity means that students, instructors, professional staff, librarians and others have a role in governance and decision-making.

The Facilities team has done a superb job, working around-the-clock to keep the campus safe and clean. President Cole announced that the University Foundation had elected a new chair, Greg Collins, 79', who will be the Foundations first African American chair.

Dr. Cuss continued that the Board received over 80 student submissions that have been distributed to and reviewed by the Board.

Matters Presented By The President

President Cole thanked Trustee Hiltzik for his over 3 decades of service to the University, and welcomed new Trustees Tracy Higgins and Sreeni Kutam. She also welcomed Vice President for Student Life and Campus Development Dawn Soufleris to the University. President Cole reported that the University has undertaken a more rigorous Covid-19 testing program during the spring semester and encouraged all members of the University community to get vaccinated. The plan for the fall term is to resume normal on-campus operations, although, alternate scenario planning is underway. The University will hold 18 Commencement ceremonies during June for some 5,000 graduates. Enrollment is looking quite strong for the fall semester. President Cole stated that Vice President for Communications and Marketing Joseph Brennan has done excellent work in creating news coverage for the University. He and his team have generated a 50% increase in news coverage seen by over 668 Million people worldwide. U.S. Senator Robert Menendez and Congressman Bill Pascrell were on campus to announce work on a student loan forgiveness program. Dr. Cole thanked them for their continued support of Higher Education. The Feliciano School of Business was named a Top School for Students of Color. President Cole thanked Trustee Ralph LaRossa for PSEG's \$425,000 grant to continue funding the University's PSEG Institute for Sustainability Studies. President Cole closed her remarks by congratulating WMSU for being named the best college radio station in the country.

Union Report

Professor Richard Wolfson spoke on behalf of AFT Local 1904. He welcomed Trustees Higgins and Kutam to the Board thanked Trustee Hitlzik for his work transforming the University. Professor Wolfson welcomed the 7 newly appointed professional staff and congratulated those professional staff receiving reappointments and faculty members receiving emeritus status. Professor Wolfson urged greater community involvement in the Presidential Search process as well as increased joint governance on a number of issues impacting the University.
