**Notes:** This VPAT has been created by Deque Systems Inc upon completion of an accessibility evaluation based on an agreed statement of work. Validation testing performed between *June 5, 2019, and March 17, 2020,* was limited only to the evaluation of specific accessibility issues that were already reported.

**Evaluation Methods Used:** A combination of automated and manual testing techniques were employed for the accessibility assessment. This assessment was completed using Windows 10, Firefox, and NVDA.
