Combating human trafficking requires a comprehensive, multidisciplinary effort. Within government, this means the participation and coordination among agencies with a range of responsibilities, including criminal enforcement, labor enforcement, victim outreach and services, public awareness, education, trade policy and promotion, international development and programs, customs and immigration, intelligence, and diplomacy.

State Organizations/Programs :

This section summarizes the anti-trafficking efforts of the State of New Jersey.

In New Jersey, there are several state laws and programs run by various state agencies addressing human trafficking. Some key milestones include:

In 2013, the New Jersey Legislature passed the "Human Trafficking Prevention, Protection, and Treatment Act", which established comprehensive measures to support survivors and stop traffickers. It set up the Human Trafficking Commission.

In 2012, the Governor signed into law Assembly Bill 5322 which provides for a process to vacate and expunge certain arrests, charges, complaints, convictions, other dispositions, and DNA records, associated with violations by certain human trafficking victims.

In 2022, the Department of Education releases guidelines for schools on the Prevention of Human Trafficking of Students.

In 2023, the New Jersey Attorney General's Office establishes a human trafficking unit within the Division of Criminal Justice.

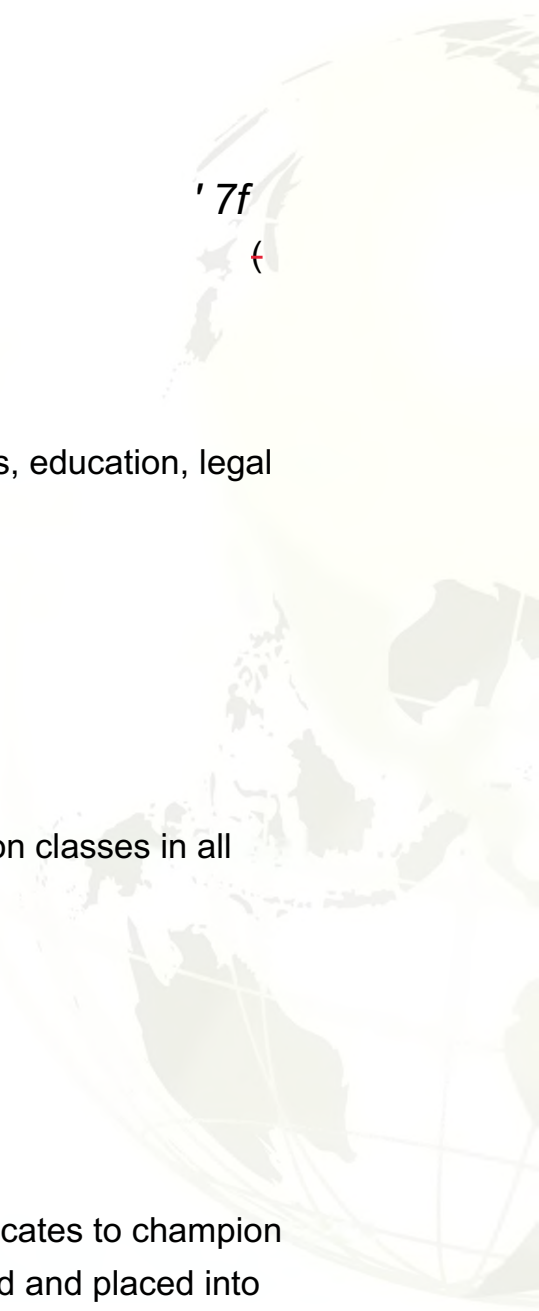
