#### **II. New Business**

# a. Sponsorship

Chris Cottle made a brief statement on the purpose of sponsorship. Sponsorship assists organizations on campus with event/ program opportunities with funds to be used for refreshments, etc. However, the monies may not be used to pay speakers at any event.

Meneghin, reminded the Commission that our annual budget is \$5,000 and we spend a large portion of the budget to assist in sponsorship.

Meneghin gave way for Dr. Cole to address the Committee.

#### III. Dr. Cole's Annual Charge

Dr. Cole stated that "as we live in a complex word she appreciates the work of the PCAAD." She thanked the committee for being humane with all that is going on in the world. Dr. Cole in her address, expressed that we do better than most here at MSU because of the unity and core value of the MSU community than those outside of our Community. Dr. Cole feels strongly on the quality of our exceptional community and acknowledges that more work is needed.

Her message included, hope for the world, where there would be fewer problems and the world would be easier to live in, with less conflicts. We are to keep our focus on the mission of MSU more than ever and to maintain our core values. At MSU we will continue to do the right thing in preparing our students for life for the world, once they leave this community.

Dr. Cole asked for any issues that the commission should address, and a conversation was had on the Office of Social Justice & Diversity to be inclusive in a major way in the work of the Commission.

Dr. Cole introduced Shante Palmer, Director of Government Relations and Keith Barrack, Chief of Staff. She also stated how she is excited about the growth of the Freshman Class this year. The Class reflects an increase in population of 21% of African American students and 34% of Hispanic students. As Dr. Cole continued to express her excitement, she expressed how we are a majority/minority University with a population that reflects everybody. In building understanding among ourselves, we do not focus on sensitivities, we focus on and nurture our strengths. In doing so, our students should go out into the world prepared and feeling that they can withstand anything with a sense of sureness of who they are.

Before leaving, Dr. Cole expressed that she is available to the Commission for any issue if needed.
