I. Points of Information:

1. **Question**: Reading over the bid, there do not appear to be any changes from the original bid. Can you confirm?

Response: The original RFP included both Preventative Maintenance/Emergency Service/Repairs and Off-Site Monitoring. This RFP includes Preventative Maintenance/ Emergency Service/Repairs only. Please see Section 3.0 Commodity Description/Scope of Work.

2. **Question**: In the RFP Document, and specifically Appendix 1, item 1, Standard Contract Terms and Conditions, the link to the website is not functional. We went to the University MSU Procurement page and found the Standard Terms and Conditions. Is this the same document or is there another one for this RFP?

3. **Question**: For the emergency generators listed in the RFP, are there any spare parts in stock?

Response: There is no generator stock storage on site, all parts and materials need to be stored off site and transfer to the site as needed.

4. **Question**: Is there intended to be a transition period (90-120 days) from contract execution to verify what spare parts are in stock, and purchase and stock whatever is required? Would Montclair State agree that parts availability would be subject to any supply chain issues to acquire them?

Response: There is no transition period and the University doesn't have any parts in stock. All standard stock parts for generators must be available from contractor's stock or its suppliers for same day delivery or overnight delivery. These generators are 100% fire life safety and critical system generators that require immediate repair. Please see paragraph 3.2.2 for additional information.

5. **Question**: The term of the agreement is for three (3) years, with two (2) 1-year extensions, for a potential total of 5 years with extensions?

Response: That's correct. Please see paragraph 7.2 Contract Term and Extension Option.
