1		Per the Contractor's Request for Classification Form (DPMC-27) available at the <u>Division of Property Management and Construction (nj.gov)</u> website, a contractor classified in trade C009 shall be classified for the following trades: C010, C011, C012, C013, C014, C015, C016, C017, C018, C019, C020,C022, C054, C057, C059, C073, C077, C080, C089. C008 is <i>not</i> among the classifications listed. Therefore, if you do not possess a C008 classification, your firm will not be eligible to bid on this project.
