Bidders are required to comply with the requirements of <u>N.J.S.A.</u> 10:5-31 et seq. and <u>N.J.A.C.</u> 17:27 et seq. regarding Affirmative Action; State of New Jersey Prevailing Wage Rate Act, <u>N.J.S.A.</u> 34:11-56.26 et seq.; and N.J.S.A. 52:25-24.2 regarding Ownership Disclosure. Bidders shall also be classified by the Division of Property Management and Construction (DPMC) and possess a valid CLASSIFICATION # C045- Sprinkler Systems with a minimum aggregate rating of \$2 million or more at the time of proposal submission and contract execution. Montclair State University is an Equal Opportunity Purchaser.

In accordance to N.J.A.C., 17:14-1.2 et seq. and Executive Order 71, signed by Governor James E.
