Dear Colleagues,

On behalf of Vice President Jack Shannon and myself, I'm pleased to welcome you to the 2nd Annual Grant Recognition Reception. During the 2013 calendar year, Montclair State University faculty and staff received more than 185 awards through the Office of Research and Sponsored Programs and the Division of University Advancement, totaling approximately \$13.2 million. These awards come from an expanding and diverse list of external sponsors including federal, state and local agencies, as well as private foundations, corporations and international organizations.

Despite significant cuts in federal research spending, federal sponsorship at Montclair State increased by 15.3 percent in FY 13, to \$5.8 million, highlighted by a near 79 percent increase in funding from the National Science Foundation. It's clear that Montclair State University faculty and staff remain committed to submitting competitive proposals in support of their research, scholarly and service activities in these challenging times.

Nationally, corporate giving budgets were flat in 2013, and foundation assets are still significantly lower than they were at the end of 2007. However, through the efforts of University Advancement and its partners across campus, corporate giving rose \$42,823 (almost six percent) and foundation giving rose \$379,825 (almost 35 percent) in FY 13. Overall, grants were up \$91,635 (five percent).

To all of those who have applied for and received support, we congratulate you and wish you continued success. To those who will revise and resubmit, we applaud your persistence and determination and wish you better fortune going forward. To all of our faculty and staff, we thank you for the creative talents and innovative thinking you bring to Montclair State University.
